Context: the INF-ACT Foundation was created as Hub to allow operations, coordination and monitoring of the project "One Health Basic and Translational Research Actions Addressing Unmet Needs on Emerging Infectious Diseases (INF-ACT)", funded through Mission 4 (Education and Research), Component 2 (From Research to Enterprise) – Investment 1.3 of the National Reprise and Resilience Program (PNRR), ref. Avviso MUR n. 341, 15/03/2022. This project was funded with 114.5 million euros and involves 25 participating public and private partners. The project structure includes five research nodes, representing the National scientific excellence and the most prominent research challenges regarding Emerging Infectious Diseases. The INF-ACT Foundation and the Program Research Manager workplace are in Pavia, Corso Strada Nuova, 65.

Activities: The Program Research Manager will develop the operational activities of the INF-ACT research program, following guidance from the Board of Directors and the Scientific Steering Committee of the Foundation. He/She will be in charge of implementing and reaching the INF-ACT project objectives through coordination and organization of the project's work.

In particular, the PRM will:
